A check or money order for the full amount must accompany the entry form. Absolutely no entries taken after April 13th---all entries must be notarized—no exceptions. A \$5 late entry fee will be assessed and collected before the performance. A \$20 returned check fee will be charged. Only cash will be excepted when fees are paid on site. The girl and boy with the most points (pee-wee to senior) will be awarded the all-around saddles. Team roping points do not count towards all-around saddle, and Little People are not eligible to win the all-around saddles. In the event of a tie for the all-around saddles, the tie will be broken with “most events” and/or “head to head” contestant analysis. All CTJRA Rules will apply unless otherwise noted in the rodeo office. A barrier will not be used. Helmets required in all roughstock events including Mutton Busting. All participants must furnish their own equipment. No horses on the grass except in specified areas. Horses may not be tied to the fences or trees.
